X-RITE, INCORPORATED USER AGREEMENT AND SOFTWARE LICENSE TERMS

By using all or any portion of the software, you signify that you have read this Agreement and accept its terms. If you do not agree to the terms of this Agreement, then X-Rite, Incorporated is unwilling to license the Software to you, in which event you should return the product immediately for a refund. The right to return and refund does not extend to your transferee.

This X-Rite, Incorporated User Agreement (the "Agreement") is a legal agreement between you and X-Rite,

Incorporated (X-Rite) for **MonacoOPTIX**. In this Agreement, the term "Software" means MonacoOPTIX and **MonacoOPTIX Pro**, including computer software and associated media and printed materials, and may include "online" or electronic documentation. The term "You" or "you" means the company, entity or individual who is acquiring the license to use the Software under this Agreement. The term "Use" means storing, loading, installing, executing or displaying the Software. "Computer" means a central processing unit ("CPU") or group of CPU's, that accesses its or their own individual non-cache Random Access Memory. The term "Profile" means the data stored in look-up tables for characterizing various input, display, and output devices (collectively, "Devices"). Profiles are used for providing transformations between well-defined color metrics and for device characterization and calibration.

License Grant - Usage in General. Except as otherwise specifically set forth below, (a) X-Rite grants you and

you accept the non-exclusive, non-transferable right to Use the Software in object code form only;

and (b) you may not modify the Software or disable any licensing or control features of the Software. You acknowledge that the Software may contain software procedures or other mechanisms ("License Enforcement mechanisms") that enforce use restrictions and that may disable functionality of the Software and prevent access to data using the Software at the end of any evaluation period or upon violation of the terms of this Agreement.

License Grant - Restrictions on Profile Use. Profiles created with the Software, are licensed solely for the

following uses:

(a) Profiles may be used for the specific display, input or output devices owned by you, for which devices

Profiles were created;

(b) Profiles may be shared with third parties for proofing purposes provided that Profiles (i) are

embedded within an image or publication; or (ii) sent to a service provider along with an image or

publication for use exclusively with such image or publication; or

(c) Profiles may be used by a third party on a specific display, input or output devices owned by such third party, for which devices Profiles were created as part of your commercial profiling service to such third party.

Except for the above, you may not yourself or through any other person, and you may not permit any third party to, do any of the following: (i) sell, license, sublicense, lease, rent, lend, disclose, permit access to, or transfer to any third party, whether for profit or without charge, Profiles; (ii) allow any third party to use the Profiles; or (iii) distribute to any third party the Profiles on any media, over networks, electronic bulletin boards, or websites. You may not distribute in any form the Profiles created under this agreement to use with your hardware or software. You will need a separate distribution agreement with X-Rite for such purposes.

Content. To the extent that the Software enables you to access (on-line or otherwise) materials not supplied by

X-Rite ("Content"), you should be aware that such Content is the property of the applicable Content owner and may be

protected by applicable copyright law. This License grants you no rights to Content.

Ownership. You acknowledge and agree that the Software is owned and copyrighted by X-Rite or its third

party suppliers. Your license confers no title or ownership in the Software or any product created with the Software

(including without limitation, any Profiles) and is not a sale of any rights in the Software or such product. All ownership rights remain in X-Rite or its third party suppliers, as the case may be.

Copies. You may only make one copy of the object code of the Software solely for backup or archival purposes or when copying is an essential step in the authorized Use of the Software. You must reproduce all copyright and other proprietary or restricted rights notices in the original Software on all authorized copies. You may not copy any of the enclosed books or printed materials, which are part of the Software.

Additional Restrictions. Except to the extent permitted above, you may not: permit other individuals to use

the Software; permit concurrent use of the Software; modify, translate, reverse engineer, decompile, disassemble, or

create derivative works based on the Software; copy (including copying onto a bulletin board or similar system) the

Software other than as specified above; rent, lease, grant a security interest in, or otherwise transfer rights to the Software except as set forth in "**Transfer**" below; modify, disable, attempt to circumvent, or otherwise interfere with any License Enforcement Mechanisms (and you acknowledge that any attempt to do so may be a violation of applicable law) or remove any proprietary notices or labels on the Software. If you are using the Software in any country in the European Community, the prohibition against modifying, translating, reverse engineering, decompiling, disassembling or creating derivative works based on the Software does not affect your rights under any legislation implementing the E.C. Council Directive on the Legal Protection of Computer Programs.

Transfer. You may transfer your license to the Software only upon the terms of this section. You must deliver

the original and all complete, partial or electronically stored copies of the Software and related documentation to the

transferee. You may not retain any copies of the Software or related documentation, and any copies you have made

which you have not transferred to the transferee you must destroy. The transferee must complete and return to X-Rite a

Product Registration Card available from X-Rite. The transferee must accept these Terms as a condition of the transfer.

Your license will automatically terminate upon any transfer of the Software. You have no right to sublicense, loan, rent or lease the Software.

Dual-Media Software. You may receive the Software in more than one medium, for example CD-ROM or

magnetic disks. You may use only one medium that is appropriate for your single hardware product. You may not use or install the other medium on another hardware product. You may not loan, rent, lease, or otherwise transfer the other

medium to another user, except as part of the permanent transfer (as provided above in "Transfer") of the Software.

Upgrades. If the Software is an upgrade of an X-Rite product, you now may use that upgraded product only in

accordance with this Agreement. If the Software is an upgrade of a component of a package of software programs that

you licensed as a single product, the Software may be used and transferred only as part of that single product package

and may not be separated for use on more than one Computer. You may not loan, rent, lease, or otherwise transfer the

original non-upgraded product to another user, except as part of the permanent transfer (as provided above in "**Transfer**") of the Software.

Limited Warranty. X-Rite warrants that for a period of ninety days from date of delivery to you of the Software,

the Software is free from defects in materials and workmanship, under normal use. If the magnetic disks or CD-ROM's

("disks") on which Software is furnished are subjected to accident, abuse, or improper use; or if you violate the terms of

this Agreement, then this limited warranty shall immediately be terminated.

Remedies. X-Rite's entire liability and your exclusive remedy shall be, at X-Rite's option,

either repair or replacement of any defective media, in each case conditional on any media and accompanying documentation being returned to X-Rite with proof of purchase

THIS IS A LIMITED WARRANTY AND IT IS THE ONLY WARRANTY MADE BY X-RITE. TO THE MAXIMUM EXTENT PERMITTED BY LAW, X-RITE DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED. IN PARTICULAR, THE SOFTWARE IS PROVIDED "AS IS", WITHOUT WARRANTY OF ANY KIND, INCLUDING WITHOUT LIMITATION THE WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. The entire risk as to the quality and performance of the Software is borne by you. Except as provided above, should the Software prove defective, you and not X-Rite assume the entire cost of any service and repair. This disclaimer of warranty constitutes an essential part of this Agreement. The provisions of this Agreement (other than your license to use the Software) shall survive the termination of the license, or the termination or expiration of this Agreement.

Controlling Law and Severability. This Agreement constitutes the entire agreement between you and X-Rite

with reference to this transaction. **This Agreement will be governed by the laws of the state of Michigan, USA, except for that body dealing with conflicts of law**. The application to this Agreement of the United Nations Convention on Contracts for the International Sale of Goods is hereby expressly excluded. In the event of any dispute involving this Agreement, X-Rite and you each consent to exclusive jurisdiction and venue in either the state or federal courts in the state of Michigan and agrees that the prevailing party shall be entitled to its reasonable attorney fees and costs. In the event any provision of this Agreement shall be deemed unenforceable, void or invalid, such provision shall be modified so as to make it valid and enforceable, and as so modified the entire Agreement shall remain in full force and effect. No decision, action or inaction by X-Rite shall be construed to be a waiver of any rights or remedies available to it.
